#### REGULAR MEETING - 7:00 P.M

1. Call to Order - Greenwood Village City Council

The City Council of the City of Greenwood Village met in a regular session in the Council Chambers at Greenwood Village City Hall, 6060 South Quebec Street, Greenwood Village, County of Arapahoe, State of Colorado, at 7:00 p.m., following a Study Session in which Council held a joint study session with the Board of Adjustments and Appeals to review the variance criteria.

B. "Best in Colorado" for 2016 Greenwood Village Pavement Preservation Program

Tom Clayton, Director of Training from the Colorado Asphalt Pavement Association, provided an award to the Village for 2016 "Best in Colorado" Pavement Award for Preservation. He stated there were 1,100 pavement projects in the State of Colorado with 69 project nominations received and just 13 award-winning projects. Mr. Clayton stated the Greenwood Village Public Works Department is highly respected in the industry. Heath Russo was present, representing Foothills Paving and Maintenance, Inc. Engineering Inspector Ted Putman, Public Works Roads Manager John Wannigman, and Public Works Director John Sheldon were presented with the award followed by photographs.

Former Councilmember Todd inquired about whether or not any developers would be in the smaller group working on the comprehensive plan wording to which Councilmember Bullock clarified that the group would only include four Councilmembers and would be open to the public.
